Naari is one of the few hormonal/steroid API manufacturers in India, serving both domestic & international markets. Naari is not a related party to any of the promoters.

Strategic Rationale for Diversification:

Foray into API & intermediate manufacturing business to diversify its current business solely focused on Empty Hard Gelatin Capsule manufacturing business. The acquisition provides a platform to enter into Hormonal API manufacturing business. Eventually, the company intends to also get into hormonal intermediate manufacturing, which require complex fermentation based manufacturing.
